- Vendors will go through a screening process of the Fall Bazaar Committee
- Each application will be reviewed and vendors will be approved based on availability and products sold
- There will only be one vendor per product name
- You will be notified of the committee's decision within 3 business days
- Each approved vendor will receive 1 space measuring 10 x 10
- Vendors are responsible for their own tables and tent covers
- Vendors agree to clean up the space prior to leaving
- After unloading the vehicle with merchandise, vendors are to move their vehicles away from the building
- All vendors will keep booths up until 4pm when the festival is over
- No unloading will be permitted after 9am and no loading will be permitted until 4:30pm
- Booth spaces will be marked out in 10 x 10 markers. All vendor spots will be assigned
- No electricity or extension cords are permitted. Electrical power will be available for an additional fee of \$25.00
- No smoking is allowed on Our Lady of Fatima Catholic School and St. Mary of the Miraculous Medal grounds
- All approved vendors must pay the \$60.00 vendor fee within 3 business days of being approved. Vendors can mail or drop off a check directly to St. Mary of the Miraculous Medal Catholic Church, 1604 9th Ave N, Texas City, TX 77590. If fees are not paid within the 3 business day time frame, your spot will be forfeited
- No refunds will be given due to rain or other weather related conditions
